### Local Parks

First District Supervisor Brad Mitzelfelt delivered a \$300,000 check to the Phelan Pinon Hills Community Service District (pphcsd) in March. The money is earmarked for parks. Director Ken Anderson spoke to the Supervisor and reminded him that money needed to be paid to our water and parks district.

The money will be used in conjunction with \$600,000 in Prop-40 funds.

### Highway 138 Project

Caltrans will be widening State Highway 138 between the 15 Freeway and the Los Angeles County line. The goal is to make the complete stretch a 4-lane highway. There will be an open [Caltrans hearing](#) on April 6<sup>th</sup> 2010 at the Pinon Mesa Middle School on Sheep Creek Road. The meeting will start at 6:00 PM and last for two hours.
